1. APOLOGIES FOR ABSENCE

The minutes of the last meeting were approved.

2. MATTERS ARISING

The Committee thanked MD for organising a very successful Comedy Evening.

New flooring will be installed on 2/3 Feb (TV Room) and 6th Feb (Bar/Lounge). MB to arrange movement of furniture. BL to confirm with supplier whether they can install the floor with pool table in the room.

4. OFFICERS' REPORTS

A - CHAIRMAN

lain Digby has requested that the club hosts the Bucks O45 tournament on Feb 4th. This was agreed.

The Ladies 6 week squash free introduction course to squash will take start 16th January. The equivalent men's course will commence 25th February.

PSA Event hosted at Tring Squash club

The date of the event (9th-14th May 2017) has been registered with the PSA. The club has until the end of February to confirm if the event is a M5, M10 or M15 event. M10 is looking the most likely. M designates a Men's event and the figure indicates a \$5K, \$10K or \$15K prize fund.

JD suggested online ticketing for the event. The committee would need to understand whether this is feasible.

JS asked about the event finances. In addition to the prize fund there are a number of administrative costs, which are being confirmed. The funding of the event is not dependent on ticket or bar sales achieving any target.

BL is pleased with the level of intra-club competition activity. KW suggested that the Handicap & Racquet-ball (Squash57) finals are held on the same night as the club championship finals. This was discussed and the meting voted in favour, subject to checking with Malcolm Newton.

JW would like to introduce a Squash 57 handicap and junior competition.

B – TREASURER

BL read out PB's report, which indicated that the club's finances are in good shape. BL is very pleased on how the club's Treasury is working.

C – MEMBERSHIP

D - SECRETARY

MB explained that the welfare policy has been published, with input from Nigel Kerry. Junior consent forms have been sent out. Completed forms are stored at the club and coaches have access to the forms.

MB has got a quote to extend the BT Sport service. The new offer is a slightly improved deal on the current one. The committee approved extending the service.

MB has registered the pot-holes on the car park cross over with Dacorum council. Case reference 201012479529.

MB raised the question about court heating as a member has written to the committee stating that court 3 was unplayable on 29/12/16 @ 17:00 because of the cold.

In the general discussion the following points were made:-

- 1. There was no known problem with the heating at this time and it should have operated as normal.
- 2. Is the frost setting set at the right level.
- 3. In general better signage is needed about the heating as the cleaning staff regularly find that the heaters have been turned off, presumably in error. Also it is apparent that members are not aware how the additional heating on courts 2 & 4 should be used.
